## What we need from you

To achieve a qualification and to consistently give the best and most up to date advice to clients, you will need to be competent at studying and passing exams. Your historic academic or professional results are used as a guide when shortlisting, however we will also consider other factors such as experience, other qualifications and skills. As an indicator for the following qualifications, we look for:

**AAT** / **ATT** – Ideally a minimum of 5 GCSE's (or equivalent) including Maths and English and a minimum of 2 A Levels (or equivalent)

**ACA / ACCA –** Ideally a minimum of a 2:2 in your degree or equivalent, although the subject of your degree is not important
